## RedStone FCU Sweepstakes Official Rules

## NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: RedStone FCU Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old or older at the time of entry. Employees of Redstone Federal Credit Union ("Sponsor"), HelloWorld, Inc. ("Administrator"), and their parent and affiliate companies as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Each Daily Entry Period begins at 12:00 a.m. ET and ends at 11:59 p.m. ET on the same calendar day. Administrator's computer is the official time-keeping device for the Sweepstakes.
- **4. How to Enter:** There are two (2) ways to enter. Method 4 (a) requires that you have a Redstone FCU Visa Signature, Redstone FCU Visa Rewards, Redstone FCU Visa Traditional, and/or Redstone FCU Visa Business Credit Card (each a "Qualifying Card"). If you would like to participate, but don't have a Qualifying Card, visit your Redstone FCU branch to apply for one.
  - a. Make a Purchase Using your Visa® Signature, Rewards, Tradition, and/or Business Credit Card: During the Promotion Period, when you make a purchase using your Redstone FCU Visa Signature, Redstone FCU Visa Rewards, Redstone FCU Visa Traditional, and/or Redstone FCU Visa Business Credit Card, you will automatically receive one (1) Sweepstakes entry into the applicable Daily Entry Period. Non-winning entries will not be included in any subsequent Daily Entry Period drawing.
  - b. Enter Without Making a Purchase: During the Promotion Period, visit <a href="https://redstonefcu.promo.eprize.com/oamoe/">https://redstonefcu.promo.eprize.com/oamoe/</a> and follow the links and instructions to complete and submit the registration form including a valid email address (and the phone number associated with your Redstone FCU membership, if you have one). You will automatically receive one (1) Sweepstakes entry into the applicable Daily Entry Period. Non-winning entries will not be included in any subsequent Daily Entry Period drawing.

<u>Limit</u>: You may enter five (5) times per day during the Promotion Period, regardless of method or combination of methods. Multiple entrants are not permitted to share the same email address or phone number. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being an authorized account holder.

- **5. How to Opt Out:** If you made a purchase but do not wish to participate in the Sweepstakes, you may opt-out by visiting <a href="http://redstonefcu.promodev.eprize.com/oamoe/optout">http://redstonefcu.promodev.eprize.com/oamoe/optout</a> and follow the links and instructions to complete and submit the form including first name, last name, and email address. You will be opted-out once you submit the requested information. If you choose to opt out of participating at any time, you will no longer be able to enter the Sweepstakes.
- 6. Drawings: Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select each potential Grand Prize winners from all eligible entries received during the applicable Daily Entry Period, on or around ten (10) business days after the applicable Daily Entry Period. Non-winning entries will not be included in any subsequent Daily Entry Period drawing. The potential winners will be notified by email, mail or phone. Each potential Grand Prize winner (or parent/legal guardian if winner is a minor in his/her state of residence) will be required to sign and return a Declaration of Compliance, Liability Waiver and where not prohibited a Publicity Release ("Declaration") which must be received by Administrator, within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner of any prize cannot be contacted, fails to sign and return the Declaration or provide any other requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits his/her prize. Card is issued by The Bancorp Bank, Member FDIC, pursuant to a license from Visa U.S.A. Inc. Use your Visa Prepaid card anywhere Visa debit cards are accepted in the United States and U.S. Territories. The card may not be used at any merchant, including internet and mail or telephone order merchants, outside of the United States and U.S. Territories. Approximate Retail Value ("ARV") of each prize: \$1,000.00.

Prizes are non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use. Odds of winning a prize depend on the number of eligible entries received during the applicable Daily Entry Period. Limit: one (1) prize per Member. Total ARV of all prizes: \$155,000.00.

- **8. Release:** By receipt of any prize, winners agree to release and hold harmless Sponsor, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, advertising/promotion agencies, and prize suppliers, and each of their respective parent companies and each such company's officers, directors, employees and agents (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any prize.

General Conditions:** Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures, human error or any other factor impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor, in its sole discretion, may elect to hold a random drawing from among all eligible entries

received up to the date of discontinuance for any or all of the prizes offered herein. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Disputes: Except where prohibited, entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Michigan without giving effect to any choice of law or conflict of law rules (whether of the State of Michigan or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Michigan.
